# Ann and Steve Bailey Opportunity Grants for Organizations, Fiscal Year 2018

#### **OBJECTIVES**

Through Ann and Steve Bailey Opportunity Grants, which are a part of the Arts & Heritage Fund, the Arts & Culture Alliance of Greater Knoxville provides financial and technical support to individual artists and small, professionally-oriented arts and culture organizations. The goal of Bailey Opportunity Grants for Organizations is to create a more vital creative community in Knoxville by:

- Encouraging contributions to the city's economy and quality of life by arts and history organizations
- Positioning Knoxville as a community that honors arts and culture and supports the industry's efforts to achieve excellence
- Raising the public profile of arts and culture within the city and beyond

The mission of the Arts & Culture Alliance is to serve and support a diverse community of artists and arts and culture organizations.

#### **DESCRIPTION**

Opportunity grants are designed to spur continued artistic and administrative growth in innovative, entrepreneurial organizations at any stage in their development. The eligibility criteria and support structure is geared toward organizations that can demonstrate they are solid and healthy and have clear goals that can be reached with financial and professional development support. Projects that allow organizations to explore new avenues of creativity, wrestle with new ideas that can advance their work, and strengthen their existing output are encouraged.

Applicants may apply for a minimum of \$500 and a maximum of \$75,000 in support. The entire Bailey Opportunity Grants budget for FY2018 for both Individuals and Organizations combined is \$100,000.

Matching funds are not required.

Awards may include a combination of cash support, in-kind services, mentoring, workshops/seminars, and special promotional opportunities.

Collaborative organization teams are eligible to apply, however any organization may be included in only one application for funding per grant cycle.

## **APPLICATION DEADLINE**

Applications must be received by 4:30 PM (EST) on Monday, May 8. Electronic submissions to <a href="LZ@knoxalliance.com">LZ@knoxalliance.com</a> are strongly preferred.

# **USE OF FUNDS**

Grant funds must be used between July 3, 2017 and June 30, 2018.

Bailey Opportunity Grants for Organizations may be designated for (but not limited to):

- Administrative or artistic development
- Mentor relationships
- Arts- or history-related travel (conferences, workshops, gatherings)

- Conference, training, and workshop fees directly related to the organization's work
- Equipment
- Marketing and publicity efforts
- Other resources for all artistic and historical disciplines

Funds may not be used for such things as:

- Tuition expenses toward a degree
- General travel; personal or staff vacations
- Items not directly related to the organization's administrative or artistic growth and institutional development
- Retiring debts from current or past performances or exhibitions

# **ELIGIBILITY**

- 1. Organizations must be legally domiciled within 50 miles of downtown Knoxville.
- 2. Organizations must have exhibited, performed, presented and/or published artistic or historical work in a public context in Knox County within the last 24 months (2015-2017)
- 3. Applicant organizations must have attained 501(c)(3) status or be non-profit in nature. No applications from nonprofessional (pastime/hobby) organizations will be accepted at this time.
- 4. The organization's annual budget may not have exceeded \$100,000 in any of the past five years
- 5. The organization's main mission must be directly concerned with arts or history
- 6. Established as well as emerging organizations are eligible to apply. Work which pushes and expands the boundaries of your field is particularly sought.
- 7. Organization must be a member of the Arts & Culture Alliance at the time of the application and throughout grant period (see <a href="https://www.knoxalliance.com/join-renew">www.knoxalliance.com/join-renew</a>)
- 8. Requested funds must be for eligible expenses (see Use of Funds)
- 9. Organizations managed by staff, board, and relatives of staff or board members of the Arts & Culture Alliance are not eligible to apply
- 10. Collaborative organization teams are eligible to apply with cash awards shared equally among team members. Organizations may be included in only one application for funding per grant cycle.

Any question of eligibility should be directed to the Arts & Culture Alliance before the application is made.

# **GRANTEE REQUIREMENTS**

Selected organizations will be required to make quarterly reports to the Arts & Culture Alliance which may be written or conducted via one-on-one meetings with Alliance staff. Final reports, which may include an exhibition or performance of work completed during the grant period, are required in order for the organization to be considered for any future grant and program opportunities through the Alliance.

If selected as a grantee, organizations may be required to participate in Alliance-sponsored meetings, workshops, or public events. For instance, the Alliance may require organizational representatives of grantee organizations to meet, present their work/challenges, brainstorm with colleagues and presenters, and participate in formal and informal workshops and seminars.

#### **GRANT REVIEW PROCESS**

Grants will be reviewed by a three-person panel consisting of members of the Arts & Culture Alliance board and/or invitees who possess special expertise in areas included in the applicant pool. The panel members assign scores based

on how well the application addresses the Opportunity Grants Description (see page 1). Panel members will use an evaluation criteria, examining:

- Artistic excellence, historical scholarliness, quality or merit
- Creativity in concept and use of available resources
- Potential for the grant to provide strategic returns in relation to the organization's mission
- Commitment to deepening and expanding the quality of the organization's output
- Clarity of the application
- Artistic or cultural achievements/history/activity
- Timeframe of project

The panel will refer a list of finalists to the Arts & Culture Alliance. Selected grantees must commit to remaining in the Greater Knoxville area for the period of the grant (usually one year).

#### **EVALUATION CRITERIA**

The application for Bailey Opportunity Grants for Organizations includes five items.

### Application

This includes your organization's contact information and the questions:

- Give a brief description of the organization's history, and state its mission.
- What was/is the annual budget of the organization for FY 2014, 2015, 2016, 2017, and 2018?
- What is the project, opportunity, or need for which you are requesting support? What are the obstacles to your organization's success? (Is it the professionalism of the staff or access to programmatic resources?)
- Describe how you see this opportunity improving the quality of the artistic or historical output of the organization.
- How will the grant funds further the administrative effectiveness of the organization?
- What are the desired outcomes of the project, opportunity, or fulfilment of need? (i.e. Define success in terms of this grant: Increased ticket sales; more visitation/audiences; more positive media coverage; more contributed support; more and better programs).
- What is the timeline? When does it start, and what are important points in the progress of the project?
- What will be the community benefits of this project or opportunity?

# II. Programmatic Activities

Please submit as a one-page PDF representing documentation of the organization's programs, activities, and accomplishments. This document should include a current listing of your organizational activities including dates and locations. The document should be neatly organized.

# III. Support Materials

Include 3 – 5 support pieces. The purpose of these materials is to help the panel understand the kind of work you do. Please contact Liza at the Arts & Culture Alliance (<a href="mailto:lz@knoxalliance.com">lz@knoxalliance.com</a>) if you would like to submit something that cannot be uploaded.

# IV. Budget

Outline expenses related to improving the quality of your organization's artistic or administrative output (see list of eligible expenses in Use of Funds). Expenses for travel or research must be specifically related to the proposal and should be quantified by how they will further the organization's work or administrative capacity.

# V. Most Recent 990

Attach your organization's most recently completed 990 (or other required organizational tax return form) and one page financial statements for FY 2015 and FY 2016.

REMEMBER: Write clearly. Be concise. Be creative in your thinking. Demonstrate that the grant will allow you to push the boundaries of your practice in a significant way. Follow directions.
